

**RESOLUTION NO. 15-21**

**A RESOLUTION OF THE DRAPER CITY COUNCIL AMENDING THE CONSOLIDATED FEE SCHEDULE REGARDING TRAIL USE FEES.**

**WHEREAS**, the Draper City Council wishes to amend the Consolidated Fee Schedule regarding trail use; and,

**WHEREAS**, it has been 3 years since the first and initial trails event use policy and fee schedule was adopted (Res. 12-12) and since that time it has served as a stable policy for Draper City; and,

**WHEREAS**, the Consolidated Fee Schedule needs to be updated to reflect new policy (Res. #12-20); and

**WHEREAS**, the City Council finds it in the best interest of the City to protect City owned assets as well as recoup actual costs of repair/maintenance/wear caused by participants in outside agency events; and,

**WHEREAS**, the City Council wishes to establish a fair and equal trails event use policy and fee schedule to promote events and that is easy to understand so that event promoters using Draper City facilities know and understand usage rules, safety rules and relevant timeframes; and,

**WHEREAS**, the City Council hereby finds this action is in the best interest of the public's health, safety and general welfare.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:**

**Section 1.** Approval. The City Council hereby amends the Consolidated Fee Schedule in Exhibit "A" attached hereto and incorporated herein by reference.

**Section 2.** Severability. If any section, part, or provision of this Resolution is held invalid, or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Resolution, and all sections, parts, and provisions of this Resolution shall be severable..


**Section 3.** Effective Date. This Resolution shall become effective upon passage.



(i) Trail Event use fee (per event)-----	\$200.00
(ii) Trail Event use security deposit (refundable)-----	\$200.00
(iii) Participant Fee - Corner Canyon and primitive trails (to be collected after event based on total # of participants)	
a) <del>More than 100 participants</del> -----	\$5.00 per participant
All Bike events-----	\$5.00 per participant
b) 100 or fewer participants-----	\$2.00 per participant
All Running events-----	\$3.00 per participant
C) All equestrian events-----	\$5.00 per participant
(iv) Participant Fee – Asphalt/paved trail use-----	\$2.00 per participant
