

## RESOLUTION NO. 17-21

### A RESOLUTION OF THE CITY COUNCIL ANNEXING PROPERTY TO THE TRAVERSE RIDGE SPECIAL SERVICE DISTRICT AND REPEALING RESOLUTION 16-67

**WHEREAS**, the Draper City Council, by Resolution 99-82 dated December 28, 1999, has previously established the Traverse Ridge Special Service District for the purpose of providing transportation, including snow removal, street lighting services, repairing and maintaining roads, and sweeping and disposal services; and

**WHEREAS**, the Draper City Council approved Resolution 16-67 annexing land owned by MREC DAI Edelweiss into the Traverse Ridge Special Service District; and

**WHEREAS**, the lieutenant governor has not issued a certificate of annexation; and

**WHEREAS**, Draper City has recently received an amended annexation petition from MREC DAI Edelweiss seeking to modify the area to be annexed into the Traverse Ridge Special Service District for the purpose of providing the same service provided by said District; and

**WHEREAS**, the Draper City Council, in accordance with Utah Code Ann. §17D, Chapter 1, Part 4, has held the required meetings to annex the property into the Traverse Ridge Special Service District; and

**WHEREAS**, the Draper City Council finds it is in the best interest of the city and the general health, safety and welfare of the public that Draper City and, specifically, the future citizens of the area covered by the petition, to annex said area to the Traverse Ridge Special Service District; and

**WHEREAS**, the petition complies with all requirements of Utah Code Ann. §§17D-1-401 and 402.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:**

**SECTION 1. Annexation.** That certain real property particularly described in Exhibits A and B attached hereto, is hereby annexed into the Traverse Ridge Special Service District.

**SECTION 2. Resolution 16-67 is Repealed.** Resolution 16-67, which was previously approved, is hereby repealed.

**SECTION 3. Waiver.** The notice, hearing and protest requirements of UCA 17D-1-205, 17D-1-206 and 17D-1-207 are waived because all property owners owning property within the area to be annexed have signed the petition requesting annexation into the Traverse Ridge Special Service District in accordance with Utah Code Ann. §17D-1-402.

**SECTION 4. Services to be Provided.** Those improvements, purposes, and services identified in Resolution 99-82, establishing the Traverse Ridge Special Service District, shall be

provided in the same manner to the annexed areas from the effective date of this resolution.

**SECTION 5. Property Subject to Taxation.** Dating from and after the approval and adoption of this Resolution, the territory annexed hereby and described in Section 1 above shall be an integral part of the Traverse Ridge Special Service District. The taxable property located therein shall be subject to taxation for the purposes of the Traverse Ridge Special Service District, including the payment of any bonds and other obligations thereof now outstanding or hereafter authorized and issued. All properties and users of serviced in the Special Service District, as enlarged by this annexation, shall be subject to all of the laws, regulations, powers and authority of the District and Draper City Council as provided by law.

**SECTION 6. Notice of Annexation.** The City Council, as the governing authority of the Traverse Ridge Special Service District, shall cause a notice of annexation and a copy of this Resolution to be filed with the Utah State Tax Commission, Utah Lieutenant Governor's Office, the Utah and Salt Lake County Assessor, and the Utah and Salt Lake County Recorder as per Utah Code Ann. §17D-1-403.


**SECTION 7. Severability.** If any section, part or provision of the Resolution is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of the Resolution, and all sections, parts and provisions of the Resolution shall be severable.

**SECTION 8. Effective Date.** This Resolution shall become effective immediately upon passage.

## Exhibit A

Legal Description:

### **Edelweiss Phase 1a Subdivision Boundary**

A part of the Southwest Quarter of Section 10, Township 4 South, Range 1 East, Salt Lake Base and Meridian, U.S. Survey in Salt Lake County, Utah:

Beginning at an angle point in the North Line of Stoneleigh Heights at Suncrest Phase No. 2A a planned unit development located 315.92 feet South  $89^{\circ}44'21''$  East along the Quarter Section Line and 1317.61 feet South  $0^{\circ}00'05''$  West from the West Quarter Corner of said Section 10; and running thence North  $0^{\circ}00'05''$  East 223.76 feet along an Easterly Boundary Line of said Stoneleigh Heights Phase No. 2A and Phase No. 1; thence North  $66^{\circ}42'39''$  East 307.53 feet; thence South  $39^{\circ}53'02''$  East 196.00 feet; thence South  $50^{\circ}06'58''$  West 13.63 feet to a point of curvature; thence Southwesterly, Southerly, and Southeasterly along the arc of a 15.00 foot radius curve to the left a distance of 23.56 feet (Center bears South  $39^{\circ}53'02''$  East, Central Angle equals  $90^{\circ}00'00''$  and Long Chord bears South  $5^{\circ}06'58''$  West 21.21 feet) to a point of tangency; thence South  $39^{\circ}53'02''$  East 11.03 feet to a point of curvature; thence Southeasterly along the arc of a 32.00 foot radius curve to the left a distance of 27.93 feet (Central Angle equals  $50^{\circ}00'00''$  and Long Chord bears South  $64^{\circ}53'02''$  East 27.05 feet); thence South  $0^{\circ}06'58''$  West 46.00 feet; thence Northwesterly along the arc of a 78.00 foot radius curve to the right a distance of 27.10 feet (Center bears North  $0^{\circ}06'58''$  East, Central Angle equals  $19^{\circ}54'17''$  and Long Chord bears North  $79^{\circ}55'54''$  West 26.96 feet); thence South  $0^{\circ}06'58''$  West 104.66 feet to the North Line of Stoneleigh Heights at Suncrest Phase No. 1; thence North  $89^{\circ}53'02''$  West 400.52 feet along said North Line to the point of beginning.
