**A RESOLUTION AMENDING THE CONSOLIDATED FEE SCHEDULE OF DRAPER CITY REGARDING THE FALSE ALRM FEES AND AMPHITHEATER FEES.**

**WHEREAS**, the Mayor and City Council wish to update certain fees shown in the Draper City Consolidated Fee Schedule to better recover the cost of providing the related services; and

**WHEREAS**, the City Council hereby finds this action in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH AS FOLLOWS:**

**Section 1.** Approval. The City Council hereby amends the Draper City Consolidated Fee Schedule as shown in Exhibit "A" attached hereto and incorporated herein by reference.

**Section 2.** Severability. If any section, part, or provision of this Resolution is held invalid, or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Resolution, and all sections, parts, and provisions of this Resolution shall be severable.

**Section 3.** Effective Date. This Resolution shall become effective immediately upon its passage.

##### Residential

- ~~(i) Begins on the 3<sup>rd</sup> false alarm~~-----Warning letter sent
- ~~(ii) Begins on the 4<sup>th</sup> false alarm~~-----\$110.00

#### B) Late Fees - fees are due on the date the notice is issued by the City: (Res 02-35) (Res 06-54) (Res 08-41)

- ~~(i) Fees not paid within sixty (60) days have a penalty of 50% on the total unpaid balance including any unpaid late fees.~~
- ~~(ii) Fees plus penalties not paid within ninety (90) days will be sent for collection for all penalties, costs and attorney's fees. An 18% fee will be assessed for all balances, collection penalties, costs, and attorney's fees beginning 30 days after the notice is issued~~

~~C) Interest Fees are assessed on any unpaid obligations due Draper City with an outstanding balance in excess of 30 days from the date of the invoice at a rate of 18% annually or 1.5% per month. (Res 08-41)~~

#### F) Amphitheater Fees (Res. 12-12) (Res. 12-36)

- (i) Amphitheater Rentals NOT charging admission. Rentals are for a total of 4 hours each.

(a) Tier #1 (under 200 users, front of stage and seating area only) -----~~\$100.00~~\$175.00

(b) Tier #2 (201-500 users, includes inside of stage, restrooms, house sound, seating area)--  
~~\$200.00~~\$375.00

(c) Tier #3 (501-2000 users, includes i & ii plus use of house lights & dressing/green rooms)--  
~~\$450.00~~\$600.00

- (iii) Optional rental items during private rental

(a) Lights cues/light show by staff-----\$40.00

(b) House video projector and screen-----\$50.00

(c) Piano-----\$50.00

(d) Piano tuning prior to rental-----\$150.00
