

RESOLUTION NO. 13-47

A RESOLUTION OF THE DRAPER CITY COUNCIL AMENDING THE CONSOLIDATED FEE SCHEDULE REGARDING THE RESERVATION AND RENTAL OF THE EQUESTRIAN CENTER PARKING LOT

WHEREAS, the Mayor and City Council want to ensure that all Draper City facilities are scheduled through and used with approval from the City; and

WHEREAS, the Council finds it in the best interest of the City to protect City-owned assets as well as re-coup actual and future costs of supplies as well as repair/maintenance/wear and tear caused by participants of outside agency events and private use; and,

WHEREAS, the City Council wishes to establish a fair and equal user fee for “exclusive use” rights to rent and use a publicly owned facility in Draper; and,

WHEREAS, the parking lot at the Equestrian Center is used as a “staging” site for multiple events consisting of trail events as well as road events, and these events can take up the entire parking area for private use including canopies and booths, leaving little or no room for general public use; and,

WHEREAS, the use or reservation of the parking lot for these events sometimes limits or eliminates the use or rental availability of the Equestrian Center Arena itself and the rental income of the area; and

WHEREAS, the reservation fee will provide an additional revenue source to the City and help better maintain the facility for events,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:


Section 1. Amendment. The Draper City Consolidated Fee Schedule is hereby amended to read in part as shown in Exhibit “A,” attached hereto and incorporated herein by this reference.

Section 2. Severability. If any section, part, or provision of this Resolution is held invalid, or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Resolution, and all sections, parts, and provisions of this Resolution shall be severable..

Section 3. Effective Date. This Resolution shall become effective immediately upon passage.



DRAPER CITY CONSOLIDATED FEE SCHEDULE

16. EQUESTRIAN ARENA RESERVATIONS

- A) Arena Reservation Fee (Events charging no admission)
 - (i) Day Show – 9 am – 10 pm -----\$200.00
plus \$100.00 clean-up deposit (\$10.00 non refundable)
 - (ii) Daily charge for use of arena lights -----\$15.00

- B) Groups Charging an Admission Fee-----\$300.00 per day
plus \$100.00 clean-up deposit

- C) Arena Reservation Fee - Draper City Residents All Youth/Adults Equestrian Groups
(less than 4 hours) -----No Charge

- D) Arena Reservation Fee – Non-Draper City Residents Youth/Adult
(less than 4 hours) -----\$20 per hour

- E) Parking Lot Only for event use (No Access to Arena)-----\$50 per day
