

ORDINANCE NO. 1043

A DRAPER CITY ORDINANCE ENACTING DRAPER CITY MUNICIPAL CODE 3-1-045 TO REFLECT THE ADDITION OF ASSISTANT CITY MANAGER TO THE CITY'S ORGANIZATIONAL STRUCTURE

WHEREAS, the City Council deems it necessary and appropriate to add a section to the Draper City Municipal Code to create an Assistant City Manager position; and

WHEREAS, the City Council finds it is in the best interest of Draper City and the general health, safety and welfare of the public that these changes to Title 3 of the Municipal Code should be made;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:

SECTION I. **Enactment.** Draper City Municipal Code Section 3-1-045 is hereby enacted to read:


Section 3-1-045 Assistant City Manager. There is hereby created the position of Assistant City Manager who shall act under the direction of the City Manager. The Assistant City Manager shall have such powers and duties as designated by the City Manager. The Assistant City Manager shall be selected by the City Manager and appointed by the Mayor with the consent of the City Council.


SECTION II. **General Repealer.** Ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION III. **Effective Date.** This Ordinance shall become immediately.

ORDINANCE NO. 117

AN ORDINANCE TO AMEND THE CHARTER OF THE CITY OF DRAPEL, MISSOURI, BY CHANGING THE NAME OF THE CITY TO DRAPEL, MISSOURI, AND TO REPEAL ALL OTHER ORDINANCES AND RESOLUTIONS TO THE CONTRARY.

WHEREAS, the people of the City of Drape, Missouri, have petitioned the Board of Supervisors to change the name of the City to Drape, Missouri, and to repeal all other ordinances and resolutions to the contrary;

AND WHEREAS, the Board of Supervisors has considered the petition and has determined that it is in the best interests of the City to change the name of the City to Drape, Missouri, and to repeal all other ordinances and resolutions to the contrary;

NOW, THEREFORE, the Board of Supervisors has passed the following resolution, to-wit:

RESOLVED, that the name of the City of Drape, Missouri, be changed to Drape, Missouri, and that all other ordinances and resolutions to the contrary be repealed.

IT IS HEREBY ORDERED that the Board of Supervisors do hereby enact and give effect to the above resolution, and that the City Clerk be and he is hereby authorized to cause the same to be published in the official newspaper of the City, and to cause the same to be recorded in the office of the County Recorder of Jackson County, Missouri, and to cause the same to be recorded in the office of the County Recorder of the State of Missouri.


