

ORDINANCE NO. 1325

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF DRAPER CITY FOR 1.02 ACRE OF PROPERTY FROM RM1 (MULTI-FAMILY RESIDENTIAL UP TO EIGHT DWELLING UNITS PER ACRE) TO CN (NEIGHBORHOOD COMMERCIAL), LOCATED GENERALLY AT 11450 SOUTH 700 WEST WITHIN DRAPER CITY, OTHERWISE KNOWN AS THE WINDSOR MILL OFFICE ZONING MAP AMENDMENT

WHEREAS, pursuant to State law, Draper City has adopted a general plan and zoning map to guide the future development within the City; and

WHEREAS, from time to time it is necessary to review and amend the zoning map to keep pace with development within the City and to ensure the provision of a variety of economic uses; and

WHEREAS, the proposed zoning change set forth herein has been reviewed by the Planning Commission and the City Council, and all appropriate public hearings have been held in accordance with Utah law to obtain public input regarding the proposed revision to the zoning map; and

WHEREAS, the Planning Commission has reviewed and made a recommendation to the City Council concerning the proposed amendment to the official zoning map of Draper City, and the City Council has found the proposed zone change to be consistent with the City's general plan.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH:

Section 1. Zoning Map Amendment. The following described real property located at 11450 South 700 West within Draper City, Salt Lake County, State of Utah, previously designated RM1 as shown on the Draper City zoning map, is hereby changed to the CN zoning designation:

Beginning at the intersection of the west line of 920 West Street and the south line of 11400 South Street said point being South 89°26'50" West 997.31 feet along the section line and South 116.71 feet from the East Quarter Corner of Section 23. Township 3 South, Range 1 West, Salt Lake Base and Meridian, and running; thence South 0°26'04" West 249.40 feet along the west line of said 920 West Street; thence Southwesterly 83.81 feet along the arc of a 70.00 foot radius curve to the right(center bears North 89°34'00" West and the long chord bears South 34°44'02" West 78.90 feet with a central angle of 68°36'01") along the west line of said 920 West Street to the north line of Windsor Mill Drive; thence South 69°02'03" West 56.80 feet along the north line of said Windsor Mill Drive; thence North 20°57'58" West 171.72 feet; thence North 0°26'04" East 148.79 feet to the south line of 11400 South Street; thence North 80°59'05" East 162.20 feet along the south line of said 11400 South street to the point of beginning. Contains 44,242 square feet. 1.016 acres


Section 2. Severability Clause. If any part or provision of this Ordinance is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance and all provisions, clauses and words of this Ordinance shall be severable.

Section 3. Effective Date. This Ordinance shall become effective immediately upon publication or posting, or 30 days after final passage, whichever is closer to the date of final passage.
