

AMENDED ORDINANCE NO. 134

AN ORDINANCE AMENDING ORDINANCE NO. 134 TO CORRECT THE LEGAL DESCRIPTION OF VACATED PROPERTY ON A PORTION OF 630 EAST STREET IN DRAPER CITY, UTAH

WHEREAS, the Draper City Council vacated a portion of 630 East Street in Draper, Utah by Ordinance No. 134; and

WHEREAS, the legal description of the property vacated by Ordinance No. 134 had a clerical error; and

WHEREAS, the Draper City Council wishes to correct Ordinance No. 134 by providing the correct legal description so a recordable deed can be provided to the purchaser of the vacated property.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:

Section 1. Corrected Legal Description of Vacated Property. The property vacated by Ordinance No. 134 is as follows:


BEGINNING at a point which is 16 feet South from the Northwest corner of Lot 5, Block 24, Draperville Townsite, as located in the Southeast quarter of the Northeast quarter of Section 30, Township 3 South, Range 1 East, Salt Lake Meridian, and running, thence South 264.5 feet along the West line of said lots to the Southwest corner of said lot 5, said point being on the South line of the aforesaid Southeast quarter of Northeast quarter of Section 30, Township 3 South, Range 1 East; thence West 82.5 feet to the Southeast corner of lot 7, Block 25, Draperville Townsite, thence North 264.5 feet; thence East 82.5 feet to the point of beginning.

Section 2. No Other Modifications. No other provisions of Ordinance No. 134 are modified by this amendment.

Section 3. Effective Date. This Ordinance shall become effective upon publication or posting, or thirty days after passage, whichever occurs first.

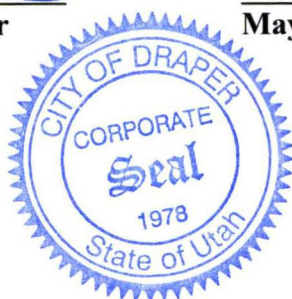
